SOUPER MISS chased the pace while three wide then made a steady advance and battled through the long drive then prevailed. PATHWAY moved up and set the pace, battled inside but was outfinished. AVA MAE was allowed to settle then ranged up while five wide and closed willingly. HAVE FAITH rated in the middle of the pack and saved ground, lacked room along the inside then ran on late. LINK TO MY HEART rated in the middle of the pack and chased between horses but tired. HOLLY AT LAW rated in the second flight inside and contended to the lane but tired. SWEETEST LIL STAR was void of speed then dropped back and passed tiring rivals. SEEYALATERTATER was allowed to settle early, split horses but faltered. LIPSTICK LADY showed no speed then angled out but made no rally. FIRST OF FEBRUARY chased the pace and battled between horses but gave way.
