M C SELENA, reserved off the second flight along the inside racing through the backstretch, shifted out entering the turn to race between foes while gaining some position, was urged to challenge three deep between foes when presented an opening nearing midstretch then edged forward to a narrow advantage to prevail in time under some right handed encouragement and steady handling. COURTESY CALL shifted off the inside early while being prompted to secure a forward placing just off the first flight, continued with a steady bid to challenge for command racing, three, then four deep into upper stretch but was just outkicked by the winner. WILDCAT HONEY, a step slow into stride, was settled between foes in the last flight racing into the bend, shifted out nearing midstretch to split foes four deep and was making solid progress in a belated bid nearing the wire. TOAST WITH HONEY was urged to secure the lead from between foes racing a bit off the inside in the opening stages, dueled for command on the turn to regain a clear advantage entering upper stretch but failed to contain the leaders while weakening in the final sixteenth. SO LONG JULIE hopped at the start losing position to the field, settled along the rail nearing the bend, saved ground on the turn gradually drawing into contention, briefly awaited an opening nearing upper stretch, then shifted out three deep to gain some position late while making no real impression. MIRKA settled off the second flight outside foes racing to the turn, made some brief progress while being fanned five wide racing into upper stretch but lacked the needed final response. TECNICA shifted out in early stages while being prompted to gain terms with the pacesetter, briefly challenged the leader in that path racing into the turn but gave way leaving midstretch when failing to match that foe AUTUMN SPLENDOR angled in sharply in the opening stages to gain a position just off the first flight, continued along the rail racing into the bend but steadily faded entering upper stretch. DYNAMICFLOWER broke inwards, was righted to track just off the second flight while caught four wide in the opening stages and retreated from contention early. FOLLOWING THE RACE THE RIDER OF COURTESY CALL LODGED A CLAIM OF FOUL ALLEGING INTERFERENCE IN THE STRETCH WHICH WAS DISALLOWED.
