**Footnotes**

SEVENTH SON broke readily, was urged to dictate the pace on a narrow margin along the inside racing into the bend, forged clear nearing upper stretch and extended the advantage to the end under pressure. FEELS LIKE FLYING broke inwards bumping DINA BOY, was quickly righted to gain a position just off the leaders along the inside tracking those foes, then continued with a steady effort into the stretch, shifting out late under pressure making contact with LOLLIPOP (ARG) while edging that foe for place honors. LOLLIPOP (ARG) was urged to terms prompting the pacesetter in the opening stages, faded after a half and was outkicked for second while being bumped late. ESPRESSO, reserved along the inside in last racing to the turn, shifted out four wide racing through the stretch and made a belated effort to improve position. COLBY TAVERN tracked off the second flight three deep between foes, was fanned five wide into the stretch but made no real impression. DADDYSPENTDAMONEY, held up between foes in the last flight early, made some brief progress to gain position racing into the bend but came up empty in upper stretch. DINA BOY, bumped at the start, settled into stride along the inside, saved ground throughout but never gained contention. MAAN was urged to gain a position outside foes in the second flight in the opening stages but dropped out early.
