CALL ME DORIE lacked speed, came five wide into the stretch and rallied belatedly for a share. KATIE'S KALLING raced close up three wide and weakened. SUE'S TRAUMA set the pace from the inside while pressed and tired. MY SWEET HEART was always outrun. WRETCHED EXCESS pressed the pace from just outside and tired.
