**Footnotes**

ADELINA ROSE tracked the leaders three wide in the second flight racing to the backstretch, made a steady advance in that path to gain terms with the first flight on the far turn, forged clear in upper stretch and held sway to the end under pressure. MULATA settled well off the pace in the opening half, circled foes five wide racing into upper stretch and continued well to prove best of the others. CAT BELLS was reserved off the inside in the opening stages, made some progress three deep between foes on the second bend, was shuffled a bit racing in close quarters entering upper stretch, but split foes four wide in the last furlong to gain a share. LUCKY GAL, held up out of close quarters in the opening stages, tracked the pace along the rail off the second flight into the backstretch, shifted out a bit to bid between foes racing into upper stretch but was outkicked. HOT KITTEN settled along the inside in the opening half, saved ground into upper stretch and made some mild progress inside foes. HOLLY AT LAW tracked just off the leaders racing to the far turn, switched out to chase the winner three deep into upper stretch but failed to sustain that effort through the last furlong. VAULTS LAST SISTER, crowded a bit racing between foes into the turn, tracked the leaders between foes in second flight to the second bend, made some progress to bid between foes entering upper stretch but lacked the needed late response. POBRECITA worked her way to the inside to track the pace as part of the second flight, was eased well back

out of contention entering the far turn, switched outside foes on the far turn, was fanned six wide racing through the stretch but made no impression. FLUID GRACE settled near the inside in the opening stages and never gained contention. PRETTY PERSUASION joined the pace outside a rival racing into the backstretch, pressed the pace racing into the far turn and gave way in upper stretch. SAGEDUST urged to the lead along the inside, dueled for command into the far turn and gave way in upper stretch.
