**Footnotes**

PURIM'S DANCER, in touch with a rival on the lead in the opening stages, stalked that foe racing into the bend while shifting outside, made steady progress to regain terms with the leader racing into upper stretch while shifting inwards making some light contact nearing the furlong marker but continued with a solid late response to wrest command and draw well clear under pressure. ANNIE PASTA, bumped, then pinched back at the break, shifted out five wide racing into the turn making steady progress and continued in that path to late stages to prevail for place honors. MS. SUTHERLAND was urged to gain the lead outside a rival from the break, set the pace along the inside through the turn, was brushed by the winner nearing the furlong marker and weakened in late stages to miss second. DESIRE TO CHANGE, bumped by WILDCAT DEVIL, then forced into the path of ANNIE PASTA at the start, was righted to gain a position inside foes off the second flight racing into the bend, shifted out while racing in some traffic nearing midstretch and finished evenly late. WILDCAT DEVIL broke outwards bumping a rival at the start, was urged to gain a contending position racing three deep into the bend, couldn't gain terms with the top

pair and steadily faded late. WAPANUCKA tracked off the second flight under rating while shifting inwards a bit racing to the turn, split foes in upper stretch and gained some position in an even effort. GOLDEN HYMN settled into stride along the inside, shifted out three deep in upper stretch to gain some position between foes but made no impact. TINY'S TALE tracked the leaders three deep in second flight in the opening stages but steadily faded racing into upper stretch. CROZETTE never gained contention. SKY KIP dropped out early. VIRTUOUS VOW was a brief factor inside foes but steadily faded racing into upper stretch. RAJULIE settled along the inside, saved ground to upper stretch and dropped into last after checking out of close quarters nearing the furlong marker. FOLLOWING THE RACE THE RIDER OF MS. SUTHERLAND LODGED A CLAIM OF FOUL AGAINST THE WINNER WHICH WAS DISALLOWED.
