Footnotes

SWEET SWAY set the pace from just off the inside, drifted slightly nearing the half mile pole causing DEB'S PRETTY LADY to shift out putting other foes in tight, inched away through the turn, was roused at the three-sixteenths and went clear under a drive until put to a vigorous hand ride through the final sixteenth. DEE DEE'S COMET stumbled at the start, was between rivals just off the pace when her lane tightened, had the rider check getting jostled between foes at the half mile pole, bouncing solidly off DEFERRAL which in turn bumped that foe heavily off stride, continued forwardly placed, got asked at the five-sixteenths, offered up a mild kick for the place honors. WINMOR GOLD two to three wide towards the rear, got asked at the five-sixteenths, offered up belated energy for the show. MYOPIA tracked the pace along the inside, came under urging at the three-eighths pole and weakened in the stretch. ARIADNA bumped at the start as DEE DEE'S COMET recovered her footing, tracked just off the inside just off the pace, came under urging three furlongs out and weakened. TAYLORS GOLDEN EYE hesitated at the start conceding about three lengths to the front, was racing three wide when angled out well off the inside to avoid the commotion down inside at the half mile pole, continued overland in the turn, got asked at the five-sixteenths and weakened. OUR DAY IN COURT towards the rear three to four wide, got roused at the three-sixteenths and offered no response. DEB'S PRETTY LADY forwardly placed two to three wide, shifted slightly nearing the half mile pole in reaction to the leader directly in front doing the same, caused DEE DEE'S COMET to be in tight between rivals along her outside, bumped and jostled with that rival steadying at the half mile pole as a result losing ground and position, chased through the turn and tired. DEFERRAL showed early speed from the four path while forwardly placed, got knocked off stride heavily at the half mile pole nearly falling at that juncture, lost significant ground and position, faded through the turn and was not persevered with thereafter.
