### Footnotes

YANKEEINDIXIELAND was strung out four wide on the turn, got set down for the drive home, was challenging RADIANT CUT in earnest for command when that rival began to come out after being on the receiving end of some left handed stick work, reacted to this herding incident by shying outward himself, drifted slightly towards the rail leaving the sixteenth pole twice, both times after some right handed pressure, went on to make some contact with the runner up after each occurrence, gamely got the job done. RADIANT CUT sat forwardly placed right from the get-go, pressed the issue of the widest of a threesome for nearly a half, turned for home holding a slim advantage and got set down, came out several paths after some left handed shots in midstretch, with the winner following suit by moving outward as well, bumped twice with that foe while still fighting hard to re claim the lead, the second time after being given some left handed pressure again, got denied. WISDOM OF OZ sat well-placed in the two path while stalking an ongoing pace dispute, remained on hold coming to the quarter pole, had clear sailing spinning into the stretch when ABSOLUTE PARADISE drifted outward at that juncture, lacked the needed response. EVASIVE CAT acted up in the gate, was backed out and re loaded, had the rider back aboard for a beat when becoming skittish again just as the field was sent on its way, spotted the penultimate breaker a four length head start, was placed along the rail well before reaching the end of the backstretch, rode it until the vicinity of the quarter pole, got fanned outward into the four path during the initial portion of the stretch run, failed to make an impact. ABSOLUTE PARADISE disputed the pace from between rivals, drifted into the three path for the commencement of the stretch and tired. CRY HOLY along the inside, argued for command with another pair contesting her to the outside for a half then faltered. WILDICHI parked out along the overland route, was outrun. An objection lodged by the rider of RADIANT CUT against the rider of YANKEEINDIXIELAND alleging interference in the stretch was not allowed.
