Footnotes

MY FOREST BABY pressed the pace from outside for a half, took charge in midstretch and drew away under left hand urging. CAYO HUESO set the pace on the rail into upper stretch and held well to best the others. ADIRONDACK WARRIOR was outrun for a half and rallied mildly. SECOND AND ONE raced just off the pace along the inside and tired in upper stretch. APPLIEDORE failed to mount a serious rally. TRIAL BY FIRE raced up close to the turn and gave way with the rider losing the whip in upper stretch. BRYNNIE'S MR. SMEE was outrun after breaking slowly. FIERY FOOTWORK stumbled then ducked in and hit the rail unseating the rider in the process. Following a stewards inquiry into the start there was no change in the order of finish.
