SUE THE ATTORNEY pressed outside for a half, took the lead inside the eighth pole and edged away under urging. RAZZLEMEDAZZLEME set the pace on the rail into midstretch and yielded late. BIRD BOX raced up close along the rail, angled out and rallied mildly. KITTYLICIOUS never reached contention. STAY CLASSY broke in the air at the start and was never close thereafter. SUDDEN SILVER chased three wide for a half and gave way. VITA VELOCE ducked in at the start unseating the rider in the process. Following a stewards inquiry into the start there was no change in the order of finish.
