MAX'S PAL rated a contentious pace, drew clear entering the stretch and finished driving. CITIZEN was pinched back at the start, tried to get out and steadied entering the turn, drifted five wide and brushed entering the stretch and up for the place. RICH DOWN pressed the pace between rivals, stayed close to the midstretch but weakened late. LORD OF TIME pressed the pace, stayed close to the rail and weakened from the eighth pole. LYRE stalked the pace outside, was brushed near the quarter pole and had no rally. TWILIGHT TIME chased the pace, was checked entering the turn and lost all chance. After a claim of foul by the last place finisher against the second place finisher, CITIZEN, there was no change in the order of finish.
