Footnotes

B D'S PHOENIX moved out early, dueled four wide, surged to the front at the quarter pole, opened a clear lead in midstretch and was fully extended in the late stages. BATTLE READY steadied along the inside on the far turn, saved ground for a half then finished well between horses but could not get up. CLONEN was outrun early, circled six wide then lugged in while gaining in midstretch. DOCTOR PROBLUM raced in midpack in the two path and rallied mildly. WANNA WINNA broke a bit slowly, saved ground on the turn, drifted four wide and closed late between horses. MARRA MARRA dueled between horses and tired in upper stretch. PAY THE JUDGE broke slowly, was outrun for a half, rallied inside in upper stretch and drifted out while finishing evenly. AFTER COLIN dueled early, steadied on the far turn and failed to threaten thereafter. COLLOONEY COUNTY stumbled at the start and never reached contention. SARATOGIAN steadied between horses in upper stretch and gave way. BROTHER OF GOLD dueled on the rail to the turn and faltered. KID DOC failed to mount a serious rally.
