DIVORCE COURT took the overland route, fought her way to the front by midstretch and edged clear under a drive. SUMWHROVRATHERAINBW had a wide journey and came home willingly to grab the place. SUPER CHILD forwardly placed throughout, was outfinished during the final furlong. MAMA BROWN spotted her opposition a substantial amount of ground at the beginning after stumbling badly, causing the jockey to check sharply and briefly come out of the irons, settled back into stride to come within shouting distance of the pack after completing a quarter, moved past rivals from the outside during the run around the bend to reach a striking position by the quarter pole, then sustaining the move, finished with good energy along the outside during the stretch run. KIARA (COL) improved her position in the lane. ED'S PRINCESS was no factor. DRIVEN BY SEATTLE had no rally. JORDANNA BANANNA was outrun. CAT GRACE failed to menace. READ THE POST on the lead along the inside, faded during the final furlong. PRIVATE SCREENING off the inside, tired.
