Footnotes

LATE STARTER made a three wide run on the opening bend to eventually secure the front by the end of the backstretch, steadily extended the margin from the top of the second turn to the its end, drew off even more after entering the stretch, finishing under a much less than vigorous hand ride. PUNSTER off the rail, appeared eager during the opening stages, requiring the rider to increase the grip on the reins at times to counteract it, picked up the pace and scooted past several rivals to become the primary pursuer during the run around the far turn, entered the stretch and although left far behind by the winner, continued on well to secure second. BUDGE MAN three wide on both turns, proved no match. J W BLUE raced along the outside and failed to menace. PHOTON tracked the front runners while taking the inside route, got shuffled back, stuck behind a tiring LITIGATE from prior to the quarter pole until past the three-sixteenths marker, angled outward for freedom and showed enough interest to improve position. SCOTUS saved ground and faltered. LITIGATE vied for the lead from the inside, failed to keep up the winner departing the backstretch and retreated.
