GLOWING EMBER underwent a three wide pursuit, closed in and challenged the pacesetter approaching the end of the turn, settled into upper stretch and was called upon, won the duel through the furlong grounds to arrive at the eighth pole as the new leader, edged away, primarily under a brisk hand ride. LUCCI THE LION cut the pace from the two path, got put to the test by the winner as the pair headed for the quarter pole, yielded, but continued on to be clearly best of the others. LEILANI'S TICKET cut the corner under a full drive, proved no match. PLEASURE PRINCIPLE three wide and set down at the five-sixteenths marker, tired. IN HARM'S WAY raced along the outside while nearly trailing throughout.
