ODEA broke alertly, set the pace inside attended early before being engaged from the seven-sixteenths, dueled through the turn, got roused cutting the corner into the stretch, shook clear to the eighth pole and was kept busy to the wire. COALITION three wide in pursuit, came under a drive at the five-sixteenths as the dueling pair up front widened away, cornered two to three wide into the stretch, offered up late energy to secure the place honors in the last jumps. ESTIMATOR attended the pace early on before intensifying the pressure at the seven-sixteenths, dueled with ODEA through the turn, spun three wide into the lane, got shaken off straightening away, kicked on willingly through the stretch then was outfinished late on for the place. WISHINGONASTAR off a beat slow at the start, settled three wide towards the rear, came under urging at the five-sixteenths, offered up a mild bid for the last major share. CREA'S LAW between foes in the two path towards the rear early on, came under a ride midway on the turn and offered no response. GREELEY'S LAW saved ground towards the rear until swinging three wide at the quarter pole and tired.
