### Footnotes

CITIFIESTA sat reserved off the inside for nearly a half, was guided over to the inside shortly before reaching the quarter pole, cut the corner under a drive, accelerating past a threesome, who had chosen a wider route into the lane, angled back to the outside soon afterwards, reached the front runner's left flank by the sixteenth pole then wore down that opponent under a hard drive to prove best. MY SIRE'S FIRE broke outward but had the lead quickly nonetheless, wasted no time angling over to the inside once sufficiently clear, drifted out a bit twice down the backstretch, causing some trouble for SISTER'S SISTER on each occasion, wandered outward a third time during the stretch drive, got caught by the top one leaving the sixteenth pole, but managed to preserve the place. WE NEED V L T'S underwent a four wide pursuit, the outermost of a threesome giving chase on the pacesetter, was put to a prolonged drive commencing from the three-eighths pole and finished willingly en route for the show. SISTER'S SPEED stalked from the outside, was taken in hand when the pacesetter drifting out slightly nearing the half mile, then brushed with another foe a short distance later, when the pacesetter came out nearly into the two path once more, was asked for some run to keep pace from midway on the turn, and weakened. BOB'S DYLAN chased between rivals for a half and folded. MISS DOLAN'S ROSE failed to menace.
