NOTEVENTHESHADOW was outrun early, advanced inside on the second turn, split rivals entering the stretch and drew away late under a drive. PRECISELY GREG raced in hand early, rallied wide into the stretch, drew clear and settled for second best. PAY THE JUDGE chased the pace while three wide and tired in the stretch. CHARITY FIGHT was outrun early, raced three wide and had no rally. PROUD YANKEE raced inside and had no response when roused. CHARRICK raced wide and had no rally. TOTHELEFTTOTHELEFT raced four wide on the second turn and tired. UHATEMECUZUAINTME contested the pace along the inside and tired. CAST THE DYE contested the pace from the outside and tired.
