PHONE ME A FAVOR was outrun early, rallied five wide approaching the stretch, dug in determinedly and was along late from the outside. GOLD GOLD GOLD was outrun early, rallied four wide on the turn and dug in gamely in the stretch. SOUTHERN SMOKE raced close up inside, came wide for the drive and finished gamely while between rivals in the stretch. QUEEN OF SARATOGA was outrun early, raced inside and offered a mild rally inside. PUCKER POWER stumbled at the start, chased the pace while three wide and tired in the stretch. DANCING DEER raced four wide and lacked a rally. SPORTIVE SPIRIT contested the pace while between rivals and tired. PERSKY (ARG) bore out badly on the turn and had no rally. TUDOR COURT contested the pace along the inside and was finished early.
