Footnotes

TRUTH WILL TELL off last, gradually improved position down the backstretch, entered the far turn and following the runner up's cue, issuing a challenge for command coming to the three-eighths pole, with the rider atop with a firm grip on the reins, went by the former pacesetter as did LYNETTE, proceeded to race as a team with the previously named foe as they headed for the quarter pole, turned together for home and got set down to a vigorous hand ride, came inward in the vicinity of the three-sixteenths pole, making some contact with LYNETTE but more importantly impeding sufficiently a rival full of run at that juncture, opened up a quick two length advantage as a result of the impediment, saw in cut down in half leaving the eighth pole, but dug in with good determination to reach the finish line first. LYNETTE settled into the two path upon arriving at the backstretch, was coaxed along prompting the early pacesetter, moved up together with TRUTH WILL TELL just as the leader was being asked for run early on the turn, made a successful challenge from between rivals to grab a slim advantage, swung over to the rail soon afterwards and entered the stretch only heads apart with the unofficial winner, was forced to check when bothered by an errant TRUTH WILL TELL in upper, having all her momentum come to a grinding halt, got going once more and staged a good comeback to close in on the leader in the late stages. RISK A CHANCE three wide into the stretch, proved no match. ROYAL SIGHTING raced along the outside and was through after completing three-quarters. DECORATED COURT was never involved. MISS TEQUILA established control just before reaching the end of the chute, showed the way from the inside, under the watchful of LYNETTE, got challenged by the two closest pursuers coming to the midway point on the second turn, succumbed readily despite being asked for run, and tired. Following a Stewards' Inquiry focusing on the stretch run as well as a claim of foul lodged by the rider of LYNETTE against the rider of TRUTH WILL TELL, the latter was disqualified from first and placed second for causing interference in the stretch.
