FERDI'S PRINCE quickly opened a clear lead, set the pace along the inside, opened up when asked and was kept to the task to the finish. PAY THE JUDGE was steadied after the start, rallied nearing the stretch and continued on to hold the place. POST EXCHANGE was bumped after the start and lacked a rally. LITES OUT chased the pace along the inside and had no rally. OMMADON'S CALL had no response when roused. SENOR MONEY BUNDLE raced wide and tired. LUNATICONTHEGRASS was bumped after the start and tired after a half mile. ITS A WHOPPER was bumped after the start and was outrun. BROADWAY MELODRAMA chased the pace while three wide and tired. NAPOLEON DYNAMITE was bumped after the start and tired.
