CLASS ACTION SUIT made light contact with SMARTY AYA leaving the starting gate, disputed the pace as the widest of a threesome, got asked for run for the initial time as the three front runners headed for the top of the lane, took control before reaching the eighth pole, then drew off, crossing the wire under a brisk hand ride. JILLISTANA came out running to secure a forward position and darted over to the rail, argued for command with two other rivals until upper stretch, fell back when no longer able to keep pace with the winner, then just held the place. SMARTY AYA brushed at the start, unleashed a four wide run on the turn to narrow the gap, sputtered a bit turning for home but got going once again when straightened away, displayed a good kick down the center of the strip, just failed to get up for the place. HOOKED ON DREAMS pressed the issue from between rivals until the three-sixteenths pole before backing away. SUNDAY TO REMEMBER came in a step or two at the break, rubbing shoulders with HEY LITTLE GIRL, raced along the outside and had no response. RED CODE under a snug hold in the initial stages, departed the backstretch from the four path, remained well off the inside for the entire way around the turn and under urging, tired after going a half. HEY LITTLE GIRL faded off a ground-saving journey. JET SET REYA off awkwardly, raced along the outside, was put to a prolonged drive, came up empty.
