**Footnotes**

THOR'S MJOLNOR just off the pace inside, ranged up from the five-sixteenths moving as a team with EAST OF DANZIG on the leader, swung three wide for home, rallied to seize command nearing the final furlong, shook off SPECIAL SELECTION in tandem with his main stretch foe battling on with that one down to the wire and held resolutely to prevail. EAST OF DANZIG just off the inside just in behind the pace, bid in tandem on the front nearing the quarter pole with the aforementioned rival, got roused swinging four wide in upper stretch, rallied with good energy through the stretch but couldn't get by the top one to the wire in a good effort. DUAL CITIZEN saved ground in mid pack, came under urging at the five-sixteenths, angled five wide in upper stretch, offered up a mild kick to secure the show. LAWYER JIM squeezed back at the start affected by pressure from SPECIAL SELECTION who came in at the break, settled three wide towards the rear, came under urging at the five-sixteenths, cornered three wide for home, offered up a mild kick to just procure the last major share. SPECIAL SELECTION came in at the start causing pressure that squeezed back LAWYER JIM as well as PROHIBITION, attended the pace from just off the inside once settled into the backside, challenged for command near the three-eighths pole, seized the front nearing the five-sixteenths, got set down swinging two to three wide into the lane, yielded the front nearing the final furlong and steadily weakened in the drive. IRISH MOON steadied early on into the first turn when in tight between rivals as they stacked across the track, settled three wide towards the rear, came under encouragement nearing the five-sixteenths, angled six wide in upper stretch and offered no response. PROHIBITION squeezed back at the start due to the pressure created when SPECIAL SELECTION broke inwards, settled just off the inside towards the rear, came under a ride three furlongs out and made no impact. SPIRIT OF PEACE four wide into the first turn, raced three wide in close range of the front, took the overland route through the far turn coming under urging midway, angled five wide in upper stretch and tired. FORTITUDE coaxed along lightly on the pace inside attended from the two path, got

challenged for command three furlongs out and displaced on the front, came under further encouragement in response, faded through the far turn then tired in the stretch.
