Footnotes

INSOLVENT bumped lightly with MADAME PROSECUTOR a stride out of the starting gate, but took control nonetheless very rapidly, sailed along on an uncontested lead, kept at a slight distance from off the rail, was in possession of a commanding advantage when finally put to a drive in the final furlong. BLUE SIXTY FOUR four wide on the turn, held on well enough to secure second. JEALOUS in the two path and under a drive prior to the five-sixteenths marker, proved no match. SHARON SPAGETTI three wide at the top of the turn, tired. GO THE DISTANCE placed in the five path at the head of the stretch, made no impact. BIRD CAY futilely chased the winner being two wide and gave way. MADAME PROSECUTOR made light contact with the top one at the start, went on to cut the corner under strong encouragement to no avail. RED CODE three wide and set down by the three-eighths pole, folded. TATOO ME three wide departing the backstretch, trailed.
