BRUSHED ON, close up from the outside while in hand, advanced four wide on the turn and outfinished pacesetter LEGAL LAND after a long drive. LEGAL LAND showed in front from the gate, set the pace then dug in gamely along the inside through the stretch. SHIMMER ME QUICK chased the pace along the inside and lacked a rally. DR J chased the pace while between rivals and lacked a rally. LAKE PONTCHARTRAIN, rated along inside, was steadied on the turn, came wide entering stretch but posed no threat in the lane. LEE'S SONNET was wrapped up for the opening half mile and had nothing in the stretch. RUBY HILL was hustled inside, came wide for the drive but had no response.
