**Footnotes**

ASK OMMADON outrun early, ranged up into contention from the outside on the turn, was swung three wide heading for the stretch run, sustained his momentum after being straightened away, made up ground gradually, drew alongside the leaders in deep stretch, took over and edged away under a drive. EDDIE'S POINT was rated while stalking the pacesetter from the outside, made his bid for the lead entering the stretch, attempted to lug in repeatedly throughout the stretch drive, even resisting strong left hand encouragement to keep a true course, brushed with MIND BOGGLING midstretch, finally lugged over to the rail deep stretch, causing EDDIE'S POINT to steady. MIND BOGGLING pressed the pacesetter, took over when that rival began to fade after going a half, faced a challenge from EDDIE'S POINT after entering the lane, was brushed and forced to steady when that rival successfully came in during the late stages. TITLETOWN TIGER rode the rail, squeezed past a rival at the three-sixteenths pole and displayed enough to best the rest. MAILBU GARDENS advanced to a striking position at the quarter pole, had little left to sustain the move. S. Z. MADISON was no factor. OUT BID retreated after a half. GOLDWYN tracked the leader along the inside, was put to a prolonged drive and tired. Following a Stewards' Inquiry as well as a claim of foul by the rider of MIND BOGGLING, EDDIE'S POINT was disqualified from second and placed third for causing interference in the stretch.
