AD ME IN raced with the pace while three wide, led into deep stretch and was caught nearing the finish. SADDLE TRAMP raced close up while wide and offered a mild rally outside. KULIA contested the pace from the outside and tired in the final furlong. JACLYN JOY chased the pace along the inside and lacked a rally. LAURA'S FURY was outrun early, raced wide and offered a mild rally outside. HIGH AUDITION raced inside and had no response when roused. KARAKORMKIPNITREAL contested the pace along the inside and tired in the stretch. E. L. A.'S SWEETIE had no rally. UPSTATE CAT had no response when roused. GYPSY'S LAST STAND was finished early. FIRST WELL trailed throughout.
