SAY TOBA SANDY raced along the outside, was steadied slightly moving past a stricken foe during the run down the backstretch, settled into a stalking position, advanced to challenge the leader when given her cue turning for home, worked her way to a slim lead at the eighth pole then proved best under good handling. DECORATED COURT inherited the lead along the backstretch, ducked towards the inside nearing the turn, showed the way under the watchful eye of the top one during the run around the bend, was put to the test after entering the stretch, surrendered the lead nearing the furlong marker, but continued on well to the finish line. LUCK steadily advanced into contention while racing towards the rail, but failed to sustain the bid. CASEY'S TRIBE broke down on the lead.
