### Footnotes

VAUGHNDIDIT sprinted clear on the rail, shook loose in midstretch and edged away while being kept to the task. ROYAL VALENTINE chased early, angled three wide on the turn but was no match for the winner while holding the place. AMERICAN LAND chased in the two path and held well to gain a share. WISE CHOICE saved ground and finished evenly. MOON DROP raced in the middle of the pack for a half and lacked a late response. LYRICAL BOBCAT was never a factor. THUNDER REIGNS failed to threaten after breaking slowly. SAND AND SONG failed to mount a serious rally. JUDICIAL LEADER faded after going a half. STEPHEN'S EVEN never reached contention.
