UNCLE SMOKEY broke out at the start and was corrected, raced just off the inside just off the pace, got asked nearing the quarter pole, spun four wide into upper stretch, took over at the three-sixteenths and edged away under a drive. PRECIOUS METAL vied three to four wide outside a pair while in hand, got set down seizing command nearing the quarter pole, cornered two to three wide for home, led briefly in upper stretch to the three-sixteenths when displaced, offered up a mild kick to hole for the place. REGGIE D broke a bit awkward at the start, settled three wide towards the rear, came under urging three furlongs out, swung six wide for home and rallied with good energy belatedly for the show. JUNIOR OFFICER three wide in mid pack, came under urging at the five-sixteenths, spun four wide for home and offered no serious response while just procuring the last major share on the wire. JOE MOOCH hustled at the start, vied inside a pair, came under urging when headed and cut the corner roused for the stretch drive, kept on mildly inside before weakening in the final eighth. M P JOE three to four wide in mid pack, came under encouragement three furlongs out, spun five wide for home, weakened in the final eighth then was vanned off after the finish. GREELEY'S LAW three wide towards the rear, came under a drive at the five-sixteenths and made no

impact. STEALTH STEED got coaxed along tracking a three way pace dispute within aim along the inside, got angled three wide into upper stretch and tired. ROCKET HERO off half a beat slow, saved ground towards the rear, came under urging at the three-eighths pole, angled five wide into the stretch and made no impact. ONE SMOKIN CAT vied between foes two to three wide, got set down nearing the quarter pole and faltered in the stretch.
