BROADWAY LADY was taken back after the start, was rated along inside, advanced three wide while under wraps on the second turn, responded when roused in upper stretch and was up with a rush from the outside. SEVEN MOONS (JPN) was outrun early, rallied four wide on the second turn, was briefly clear in deep stretch and was caught on the wire. LA MINUTA (CHI) prompted the pace from the outside and stayed on well along the inside in the stretch. CATALINA CAT was rated along early, came wide for the drive and finished well outside. DUCHESS COUNTY raced in hand along the inside, saved ground and lacked a rally. LARGER THAN LIFE raced close up outside, put in a three wide run on the second turn and faded in the final furlong. BELLES LETTRES raced wide and had no rally. PERFECT ENERGY chased the pace along the inside and tired in the stretch. EVERYBOTTIWINS raced wide throughout and tired. STOIC set the pace along the inside and tired in the stretch.
