QUICKSTONE disputed the pace from the outside, shook free after being asked for a response and drew away under hand urging to the end. FIERY FOREST patiently tracked the front runners along the inside, angled outward for the stretch drive, and finished willingly to be up for the place. INTREPID dueled along the inside and weakened during the final furlong. PERNICE eased off the inside coming to the seven-sixteenths pole, swung three wide into the stretch and rallied mildly. KNOWN GAMBLER chased three wide for three-quarters before backing off. DRIVEN BY FEAR four wide at the half mile pole, ranged up into contention during the run around the bend, but could not sustain the move after turning for home. MY TAPIT off the inside, was no factor. BLUE HORSESHOE within striking distance along the outside, was called upon at the five-sixteenths pole but came up empty for the stretch run. UNIQUE TUNE was never in the hunt. MAJESTY'S PILGRIM offered little. CRESCENT MOON DR was through after going a half.
