HOW DO I WIN broke sharply to the front, was confronted to his inside by EYE WITNESS, dueled with that rival until midway on the turn, began to edge away when confronted by COPY MY SWAGGER nearing the quarter pole, turned for home with a slight advantage, came out in the vicinity of the three-sixteenths pole bumping that rival when reacting to left-handed rein work by the rider, continued on a truer course the rest of the way, digging in determinedly while edging clear in the final sixteenth being kept busy to the end. COPY MY SWAGGER tracked the duel up front while three wide around the turn, ranged into contention under his own power to loom a threat near the quarter pole, came under a drive at that station, was bumped when HOW DO I WIN came out near the three-sixteenths under left handed drive, continued on through the furlong grounds with good energy to procure the runner up spot. KING AND CRUSADER broke in at the start and was corrected by the rider before any contact was made, chased four wide around the turn, came under encouragement midway, passed tired rivals through the stretch to procure the show. GOODTIME BOY saved ground throughout and offered little. EYE WITNESS rushed up along the rail just after the start, dueled in hand until the five-sixteenths, came under a drive at that point and steadily faded thereafter.
