MISSISSIPPI DUEL vied inside early, then tracked, bid two wide on the far turn, gained a short lead, drifted out near the furlong marker in front of LIQUIDITY TRAP, the dug in gamely in deep stretch to prevail. LIQUIDITY TRAP was bumped at the start, raced close up inside, came three wide into the lane while between horses, was bothered some nearing the furlong marker, then bumped with BECKY'S KITTEN and dug in gamely to the finish. BECKY'S KITTEN stalked outside, bid three wide on the far turn, was bumped at the eighth pole and outfinished. QUANTITY raced off the pace inside, came four wide into the lane and rallied mildly outside. FOOLISH TIGER settled off the inside, came five wide into the lane and rallied mildly outside. TORMENT was bumped at the start, had a three wide trip and lacked a rally. GIMME CREDIT raced off the pace, saved ground and failed to threaten. THOMAS HILL was

bumped at the start, pulled early and lacked a bid. YIELD BOGEY was bumped at the start, vied outside, led and gave way. JACKIN MY STYLE raced four wide early, then three wide and faded. After a Stewards' Inquiry and Jockey's Objection, MISSISSIPPI DUEL was disqualified and placed second for interference in upper stretch.
