ZIPTRONIC raced off the pace, saved ground approaching the stretch, found room on the rail at the furlong marker, burst through and kicked clear. OCEAN SEVEN (IRE) settled off the inside, angled out at the top of the lane and finished well outside. PARC DES PRINCES (BRZ) stalked the pace, bid at the quarter pole, put a head in front and was outfinished. WAYWARDWILLIE raced off the pace and rallied mildly between rivals. BISHOP OF NOLA set the pace on the inside and weakened in the final furlong. CAN'T REFUSE saved ground to no avail. TIGER WILLIE did not factor. JUDGE WELL raced close up outside a rival and failed to respond. CORVO was a bit rank leaving the chute and outrun.
