INNER DIRT FOR TWO YEAR OLDS FOALED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY. By subscription of \$75 each, which should accompany the nomination. A supplemental nomination fee of \$750 may be made by closing time of entries; \$350 to pass the entry box; \$400 to start, with \$75,000 added. All entrants will be required to pay entry and starting fees. The added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$30,000 allowed 2 lbs.; two races, 4 lbs.; a race at a mile or over, 6 lbs. (Maiden and claiming races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, November 22, 2008 with 17 Nominations. (S)

HAYNESFIELD left the starting gate sharply to grab command, was rated on the front end on an open lead while racing along the inside, emerged from the furlong grounds with a comfortable advantage and gradually increased it while being confidently handled during the final eighth. FIDDLERS AFLEET four wide around the far turn, came home with good courage to be second best. LEGAL CONSENT pursued the leader for three-quarters and gave way. THUNDER ROAR lacked a rally. TALL POPPI was never involved. ALWAYS ON THE MOVE failed to reach a contending position. KARAKORUM LEGEND stumbled at the start, appeared sluggish during the opening half. SHOW ME THE CASH saved ground and steadily tired after going six furlongs. THAT'S RICH urged on the second turn, tired. HARMONIC MAN outrun.
