TAP ATTACK raced off the pace, advanced on the turn, angled out, closed willingly in the middle of the track and drew clear. STUD MUFFIN raced three wide early, stalked outside, rallied three wide into the stretch and dug in gamely to the finish. GOOD PROSPECT vied three wide, duelled outside on the far turn and weakened. CREA'S LAW raced off the pace and passed tired ones. DREAM DROP KID was bumped at the start, raced three wide early, vied outside, duelled between on the far turn and tired. MERLIN BAY was bumped at the start and outrun. MUSTANG ISLAND vied inside, duelled on the far turn and gave way.
