HUNDRED ACRE WOOD set the pace on the inside, responded when asked and pulled away under urging. LILY LYNN raced three wide early, stalked outside, bid four wide on the turn and was well clear for the place. BOZIQUE pressed the pace and weakened. SUS ANNMARIES GOLD rated off the pace while saving ground and failed to respond. ROCK SHOW raced off the pace between foes and had no rally. KAITLYNS CAT raced three wide early, stalked the pace, bid three wide on the turn and tired. MISS TAPIT raced four wide on the backside and faded. AS PER RULING AQ 21-2014 DATED 3/25/14 FROM NYS GAMING COMMISSION, BOZIQUE IS DISQUALIFIED FROM THIRD AND UNPLACED DUE TO POSITIVE TEST.
