Footnotes

GET GORGEIOUS raced three wide early, stalked outside, bid three wide on the far turn, rallied outside and prevailed after a long drive. MADAME PROSECUTOR pressed the pace, bid between rivals at the quarter pole and dug in between horses through the stretch. SCHILLERETTE saved ground racing off the pace, angled out past the furlong marker and made a belated run outside. EVAN'S ROCKET tracked inside and made a mild bid on the rail. WHITE SANGRIA set the pace, dug in when challenged and weakened. I DREAMT I WAS stalked outside and lacked a winning bid. WHO IS LADY was off slow and bumped at the start, then outrun. A NEW YORK PHILLIE stumbled badly and was bumped at the start, raced off the rail and gave way. An Objection by the trainer of MADAME PROSECUTOR against the winner was quickly dismissed.
