MY UNBRIDLED STORM tracked inside, came out for the drive and could not threaten the winner. SEVEN DREAMS raced four wide early, stalked outside, came four wide into the lane and rallied mildly. WE'LL TALK raced three wide early, four wide on the backside and lacked a winning bid. MARY ANN'S KITCHEN vied outside and tired. FIRST PENNY had a three wide trip and tired. BEAUTIFUL RISK raced four wide early, continued three wide and did not factor. WISE CHOICE raced off the pace, saved ground on the far turn and did not factor. JAZZINGTON stalked and gave way. OUR DAY IN COURT was outrun.
