SUMMER SUNSET off to a good beginning, grabbed early control, cut the pace while racing along the inside, shook clear after entering the stretch, emerged from the furlong grounds in possession of a comfortable advantage and added to it, kept busy to the end. MONEY IN MOTION strung out three wide on the opening bend, appeared a bit eager entering the backstretch, was given some rein and rushed up to briefly confront the top one, took over the two path by midpoint after clearing a couple of opponents, prompted the pacesetter from the outside for nearly six furlongs, began to lose contact approaching the quarter pole, held on well to procure the place. PURE GRIT was squeezed back between rivals just after the break, judiciously took the inside route on the first turn before leaving the rail, proceeded around the second turn well off the inside, commenced his stretch drive from the four path at the top of the lane and rallied mildly for the show. CHIEF WILD EAGLE was bumped and knocked slightly sideways a few jumps out of the starting gate, recovered and was guided to the inside, rode the rail thereafter, was roused entering the lane, faltered. GLYNISTHEMENCE broke outward, creating enough pressure to cause some crowding in the initial stages, gave chase from the outside for three-quarters before backing away. COYOTE CANYON bumped another after being carried to the outside slightly by an errant GLYNISTHEMENCE at the start, raced three wide on the second turn and tired. SUMMER SUNSET WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR A MEDICATION VIOLATION.
