BOLD FEAT rated just off the pace, saved ground on the turn, angled out entering the stretch, rallied to the front, dueled through late stretch and edged away in the final yards. PERSONAL DELIGHT advanced to the lead on the inside then rated the pace, was tested through the turn, dueled gamely in the stretch but was outfinished in the final yards. JOYEUX NOEL was hustled to the early lead then settled in stalking the pace, challenged the pacesetter through the turn, continued to duel through the stretch and reluctantly let go in the final yards. PAUGUS BAY raced unhurriedly, saved ground through the turn, advanced on the rail through the stretch then leveled out nearing the wire. LAVISH became unsettled at the start then advanced to just off the pace, gave chase through the turn, eased out entering the stretch and leveled out. LOOK UPON raced close through the backstretch, ran seven wide through the turn and finished evenly outside. SEMINOLE GAL raced off the pace, made a mild bid through the turn, steadied entering the stretch then was empty for the drive. ACES WILD broke to the outside, raced closest early on and was outrun. BLUSHING APPEAL showed no speed, spiraled out nearing the quarter pole and offered no rally. IMPEACHABLE AFFAIR steadied at the start and was no factor. BELLA PRINCESS gave chase to the quarter pole then gave way.
