COVER CHARGER broke to front soon after break, was never seriously challenged, won in hand while increased margin to wire. HOT FIRE well positioned outside rivals from start, four wide into stretch, no match for winner in drive but clearly best of others. MY JOHNNY CASH stalked early leaders, came three wide into stretch, gave way. SHOW ME THE GLITZ wide of rivals from start, lacked response. DE ORO'S FIRESTORM dueled for early advantage, faded steadily after quarter mile. ROSS'S CRYSTAL was never a factor along inside. O'MATE wide of foes from start, never a threat. GRIND N PLAY vied with early leaders along rail, dropped back after quarter mile. HI CITY SLEW was outrun racing along inside. SKUTINSKUTERBROWN was never close. EMBLEM BOY showed little. PINCHRUNNER was always outrun.
