SUNSHINE ALPINE was allowed to settle in stride early, moved willingly circling foes leaving far turn, took command into stretch, unchallenged, ridden out to wire. PARTY WITH TODD well back for half, came four wide into stretch, responded and finished well while racing mid track. MAJOR RIVER hustled to front along rail, held gamely to top stretch, tired. FLIGHT DELAY dueled for lead on the outside of rivals from start, took narrow advantage at the half, gave way in lane. SUNDAY BERRIES was never a factor. R W DUSTY'S GIRL was always outrun.
