WOOD BE LAWYER angled to three wide at the half and rallied to edge. VISIBLE MARQ at the wire. VISIBLE MARQ assumed command from outset, opened up a clear lead and was outnodded at wire. NICK MISSED settled to lead the second flight through the opening half but was unable to match strides with top two in final furlong. HUNTERWOOD POINT improved placing with late interest to end a ground saving trip. HAWK TALK finished evenly after settling mid pack early. CLAIM THE THRONE saved ground and tired late.
