STRUM BUM stalked the early pace from two deep before responding to urging, getting up for the score. LEWKACY rallied mid track for place after giving chase from between horses through the turn. BRAHMS INFERNO was gaining ground and earned show after being reserved early. CHESTER'S DUE saved ground to no avail. CHANGING LANES trekked three wide to contend for the opening half, but came up empty in final furlong. BULLFIGHT set pace early and weakened. UNDENIABLE FACT was of little impact. ROBYNS RETURN was outrun. STORMIN STEVE trailed from outset.
