MANOVAN vied between rivals for early command and responded to the challenge of runner up in the stretch duel. TWO TURNS rushed late to challenge eventual winner in a stretch duel after a slow start. ROYAL DEVIL angled out to a four wide position at the quarter pole to contend for the win but came up empty. CURRAGH MON lacked a closing bid from a three wide position. HEAVENLY SNIP flashed early speed and led for the opening half before fading thereafter. COUNTY CLERK settled and soon fell out of contention. SUCH A DEAL failed to menace from well back.
