WOLGAN VALLEY finished with a late gain to improve placing after giving chase from the three path. RIGGAN saved ground to no avail. SEVEN POINT ONE lacked a closing bid from a ground saving trip. PREACHER'S THREAT gave way in final furlong after attending pace from between horse for opening half. FORGET THE CAT steadily weakened.
