MANOVAN led from gate to wire with a ground saving rail trip. QUICK MEETING tucked behind early pacesetters to save ground and made late rally along rail to get up for place. EDLOS TWIST dueled for lead into and through turn by latching onto the eventual winner's right hip and failed to respond in the stretch to steady left handed urging. SKIMASCO dueled with pacesetters three wide into turn before being shuffled back mid turn and lacking a late rally. COUNTY CLERK failed to menace. CITY VOW gave an even effort. OCONEE steadily faded after racing four wide through turn. OUT was outrun.
