TOCCING MAN dueled on the outside of rival from outset, came four wide into lane, responded to steady handling, gained slight advantage mid stretch, kept to task and held sway. HUNKAVICAR dueled on the inside from outset, went gamely in drive but unable to match strides with winner late but much best of others. DRB'S CRYSTAL BALL stalked leaders from outset, came five wide into lane when making bid, flattened out. CASH THE DEPOSIT vied with early leaders, faded steadily after half. HANGMAN'S GULCH was never a factor. PINCHRUNNER was always outrun.
